### **Healthcare Associated Infection Report**

The Scottish Ambulance Service (the Service) Infection Prevention and Control (IPC) Programme for 2022/2023 was developed on behalf of the Service's Infection Control Committee. The IPC work programme addresses national and local priorities for IPC and embraces healthcare, health protection and health promotion. The IPC Annual Programme of Work has been approved by the Clinical Governance Committee and ICC.

Progress on the IPC Programme of Work is reviewed and discussed at each ICC meeting, and any changes affecting its progress, or priorities (as well as changed priorities) are brought to the attention of the ICC. The Infection Control Committee were informed at the meeting in September that Terrafix are in the process of developing and testing the new vehicle-cleaning checklist. The development was scheduled to be completed by August 2022 and the new product implemented in December 2022, but the digital team have advised that implementing the new system will be delayed until the start of 2023, as a result of an upgrade to the software used for the patient's electronic record. Staff will continue to record vehicle cleaning on the daily and weekly cleaning record sheet.

#### **Review of Policies/Guidance**

The IPC team are in the process of reviewing local IPC policy and guidance. The priority over the pandemic has been COVID specific guidance, patient and staff and management of staff with respiratory infection in the Service safely and therefore this is a priority for the organisation. We are progressing with vigour to review IPC guidance that is now out with the review date and will have achieved a target 75% policies/ guidance updated by the ICC meeting on 14 September 2022. The Infection Control Committee and Clinical Governance Committee are provided with an update on the progress and changes made to IPC guidance and policy.

The National Infection Prevention and Control Manual (NIPCM) remains the core national guidance for all NHS boards, and all Service guidance/policies and standard operating procedures align with this guidance. The review of IPC guidance/policies content takes into account evidence-based practice as outlined in the *National Infection Prevention and Control Manual*, which is mandatory for NHS Scotland and includes standard infection control precautions, transmission-based precautions and healthcare associated infection (HAI) incidents and outbreaks. We also ensure that guidance/policies align with the *HAI Compendium*, which provides an overview of all up-to-date guidance from all stakeholder organisations. The policies are approved by the Infection Control Committee and, upon agreement by the members, are uploaded to @sas and then submitted to the Service's policy/guidance approval process.

#### Programme of Audit

The National Cleaning Services Specification (NCSS) is mandatory, and, as reflected in the Programme of Work 2022/2023, IPC audits of stations and vehicles remain a priority. The Service is committed to achieving and maintaining consistently high IPC standards. Monitoring these standards is a fundamental element of the IPC Work Programme, just as monitoring the NCSS is a priority, and we continue to maintain our target of 90%. The comprehensive IPC audit programme of ambulance vehicles and stations (known as the RIVO audits) are carried out every six months and continues to progress as scheduled.

The IPC team is currently monitoring the Standard Infection Control Precautions at emergency departments. This monitoring includes emergency departments in remote and rural areas, the Western Isles and the Shetland and Orkney Islands. The work is on track for its expected completion by December 2022.

#### Scottish Government – The IPC Workforce Strategic Plan

This Strategic Plan has been developed with a wide range of stakeholders including the Service's IPC team. Its two main ambitions are recovering for COVID-19 and building on learning of the future IPC services/workforce. This IPC workforce includes antimicrobial stewardship teams, IPC team and elements of Health Protection where applicable in NHS boards. The plan will assess and address current, and futures demands to allow succession planning and sustainability to ensure safe and effective clinical service delivery.

A final document is still to be circulated to stakeholders for feedback. The anticipated publication date is December 2022.

#### Air Ambulance

The head of the IPC team, supported by the infection control doctor, continues to attend meetings on the Air Procurement project and are contributing to the project to ensure that future aircraft designs meet the IPC requirements based on airborne, droplet and contact routes of transmission.

The head of IPC and the infection control doctor recently met with staff at the Aberdeen airport to discuss infection control concerns in the transfer of patients with suspected respiratory infections, including COVID-19. We discussed the proposed changes to guidance, taking into account the risk of infection and lessons learned during the pandemic.

#### Peripheral Venous Catheter (PVC) Insertion Bundle

Compliance with the PVC bundle remains above the target of 95% with compliance in, August 96.5%, September 95.9% and 96.3% October.

### Conclusion

The main components of the IPC programme and other projects continue to support the Service in preventing and reducing the risk of infection and providing safe and effective care to our patients and staff.
